REMEMBERING SEPTEMBER 11TH

We all have moments in our life when we remember the exact time and place when a big event in our life took place. 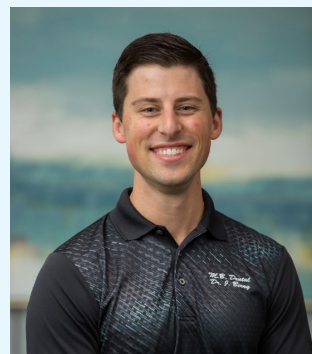


A NOTE FROM RICHARD BERRY
